In pursuance to the Notification dated: 18.12.2021 cited at (Ref-1) recruitment process to fill up vacancies of Scene of Crime Officer (SOCO) (Men & Women) (NKK & KK) in Forensic Science Laboratory and Regional Forensic Science Laboratories was initiated by adhering to all the procedures laid down in the Cadre and Recruitment Rules. After completing the process of recruitment and the procedures as laid down in the Cadre and Recruitment Rules Provisional Select List was published vide cited at reference-2. After publishing the Provisional Select List, the same was sent to the Director, Forensic Science Laboratory, Bengaluru for the purpose of verification of character and antecedents and also for document verifications.

Whereas, the Director, Forensic Science Laboratory after conducting the process of verification has sent the verification report vide letter cited at (Ref-3). As per the report, the character and antecedents and document verification have been completed for 20 candidates. Hence, they are eligible for select list. Thus as per the cadre and recruitment rules, the select list of candidates for post of Scene of Crime Officer (SOCO) in Forensic Science Laboratory and Regional Forensic Science Laboratories (FSL) is prepared and is as follows:

- a) The Select List is subject to the final decision of the orders of Hon'ble Karnataka State Administrative Tribunal / Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
- b) The fact that the name of the candidate figures in this list does not give him/her any legal right for appointment to the post.


- c) The final appointment is subject to verification of Departmental Enquires if any pending against any of the candidates from previous Government Service.
